First come first served. Any person interested in purchasing any of the specified residential properties (“<b>Prospective Purchaser</b>”) (if the Prospective Purchaser is a company, then any one of its directors) must:-</p> <p>(a) personally attend the ICC 62/F Venue; and</p> <p>(b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary. The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the Prospective Purchaser. Each cashier order shall be in the sum of HK\$100,000 and made payable to “<b>Woo Kwan Lee &amp; Lo</b>”;</p> <p>2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the ICC 62/F Venue before the commencement time of sale.</p> <p>3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting).</p> <p>4. If the Prospective Purchaser has successfully selected any of the specified residential properties, the Prospective Purchaser (if the Prospective Purchaser is a company, then any one of its directors) shall <b>personally</b> (or (if the Prospective Purchaser is an individual) his/her/its/their attorney duly appointed pursuant to a validly executed power of attorney in a form prescribed by the Vendor (a “<b>duly appointed attorney</b>”)) select the specified residential properties which are still available at the time of selection in the order of priority as determined above and in an orderly manner and within reasonable time. If the Prospective Purchaser has successfully selected any of the specified residential properties, the Prospective Purchaser (if the Prospective Purchaser is a company, then any one of its directors) shall <b>personally</b> (or (if an individual) by a duly appointed attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor) enter into one or more Preliminary Agreement(s) for Sale and Purchase of the specified</p>

5. The Vendor reserves the right to close the ICC 62/F Venue at any time if all the specified residential properties have been sold out.

If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 9:00 a.m. and 8:00 p.m. on any date of the sale, for the safety of the Prospective Purchasers and the maintenance of order at the ICC 62/F Venue, the Vendor reserves its absolute right to close the ICC 62/F Venue.
